PDCA ANNUAL MEETING PROXY VOTING FORM

Article 9.4 (b) of the PDCA Bylaws permits proxy voting by Active Members, who are current in their membership dues payments, at the PDCA Annual member's meeting on any issue.

A PDCA Active member company may give its proxy vote to another Active member by executing this form and submitting it to PDCA Headquarters no less than (24) hours prior to the beginning of the Annual member's meeting.

Active member proxy vote holders may not cast more than three proxy votes.

INSTRUCTIONS FOR TENDERING 2010 ANNUAL MEMBER'S MEETING PROXY FORMS
